

Important Notice and Change in Terms for Upgrading PC Insiders[™] World Elite Mastercard[®] Cardholders

Congratulations on upgrading your PC Financial[®] Mastercard[®] account (your "Account") to the PC Insiders[™] World Elite Mastercard[®]. Your new card comes with great new perks and benefits that are available exclusively to this product. We think you're going to love it.

Now that your Account upgrade is approved, you along with any Additional Cardholders will receive your new PC Insiders[™] World Elite Mastercard[®] cards in the mail in 7-10 business days. Along with your new card(s), we're also making some updates to your Account terms, including the PC Financial[®] Mastercard[®] Disclosure Summary you received when your Account was opened (as amended from time to time), and the PC Optimum[™] points earning rates and rounding rules for PC Financial[®] payment cards that govern the PC Optimum[™] points you earn with your Account. This Important Notice and Change in Terms (this "**Notice**") contains important information about your upgraded Account, so please review it carefully and save a copy for your records. Capitalized terms used in this Notice and not otherwise defined will have the meaning set out in the PC Financial[®] Mastercard[®] Cardholder Agreement applicable to your Account (the "**Cardholder Agreement**").

Important: This Notice is applicable only to cardholders who have requested and been approved to upgrade their existing PC Financial[®] Mastercard[®] account to the PC Insiders[™] World Elite Mastercard[®]. Cardholders who have applied for a new PC Insiders[™] World Elite Mastercard[®] should refer to the account disclosures & terms provided to you with your new account for more information.

CHANGES TO YOUR DISCLOSURE SUMMARY

Effective as of the date your product upgrade is approved, we are amending the PC[®] Mastercard[®] Disclosure Summary applicable to your Account ("**Disclosure Summary**"). The row titled "Annual Fees" in the Disclosure Summary is hereby deleted and replaced with the following:

CHANGES TO THE PC OPTIMUM™ POINTS EARNING RATES AND ROUNDING RULES FOR PC FINANCIAL PAYMENT CARDS

We are amending the PC Optimum[™] points earning rates and rounding rules for PC Financial payment cards (the "**Earning Terms**") to include the new PC Optimum[™] points earning rates that apply to your upgraded Account. The new earn rates applicable to qualifying purchases with your new Card(s) are as follows:

PC Insiders™ World Elite Mastercard®

Earn 40 PC Optimum[™] points per \$1 on qualifying purchases made with a PC Insiders[™] World Elite Mastercard[®] credit card at participating Loblaw banner stores and Joe Fresh[®] stores in Canada. For these purchases you will earn the regular 10 PC Optimum[™] points per \$1, plus an extra 30 PC Optimum[™] points per \$1 charged on your card(s) for a total of 40 PC Optimum[™] points per \$1.

Earn 35 PC Optimum[™] points per \$1 on qualifying purchases made with a PC Insiders[™] World Elite Mastercard[®] credit card at participating Shoppers Drug Mart[®] and Pharmaprix[®] stores in Canada. For these purchases you will earn the regular 10 PC Optimum[™] points per \$1, plus an extra 25 PC Optimum[™] points per \$1 charged on your card(s) for a total of 35 PC Optimum[™] points per \$1.

Earn at least 50 PC Optimum[™] points per litre at Esso[™] and Mobil[™] stations in Canada. Points amount includes the 10 points per \$1 for all qualifying purchases with a PC Financial[®] Mastercard[®]. In addition, earn at least 30 PC Optimum[™] points per purchased litre of gasoline or diesel fuel at Esso[™] and Mobil[™] stations in Canada when you pay with your PC Insiders[™] World Elite Mastercard[®]. This new version is effective as of the date your product upgrade request is approved.
